

**RULES**  
**of the fourth European Conference**  
**Buried Flexible Steel Structures**  
**held on 25-26 April 2022 in Rydzyna**

1. The fourth European Conference "Buried Flexible Steel Structures" (hereinafter the Conference) shall be held on 25-26 April 2022 at the Rydzyna Castle (pl. Zamkowy 1, 64-130 Rydzyna).
2. The official website of the Conference shall be [www.conference-flexiblestructures.com](http://www.conference-flexiblestructures.com).

6. The provisions hereof shall apply to all Participants of the Conference and constitute an integral part of registration of the participation in the Conference.
7. The Conference shall be attended by the Participants of the Conference:

  - b. Active Participant: participating in the Conference with publication of a paper and/or a presentation thereof during the Conference.
8. Participant of the Conference shall be obliged to confirm their registration of participation and to pay a conference fee.
9. The registration of participation shall be accepted only via the form on the Conference website ([www.conference-flexiblestructures.com](http://www.conference-flexiblestructures.com)).
10. The conference fees shall be:

    - ii. after 10 December 2021: PLN 1,220.00 gross;
11. All payments shall be made only in Polish Zloty (PLN). In case of payment in other currency, mid-exchange rate quoted by the National Bank of Poland (table A) on the date of payment shall be applied and payer bears all costs, fees, etc. concerning such payment in other currency.

17. The date of payment of the conference fee shall be deemed to be the date of recording the payment on the bank account set out in Clause 12.
18. The Organiser shall issue a VAT invoice for the participation in the conference for the data provided in the registration form.

20. Participant of the Conference shall be obliged to inform the Organiser by 31 March 2022 of the type of means of transport by which they will travel to the Conference.

21. The Participants of the Conference who meet the obligation referred to in Clause 20 shall be provided by the Organiser with free transportation on the following routes:

- a. transfer from the Poznań airport to the hotel and from the hotel to the Poznań airport;
- b. transfer from the Wrocław airport to the hotel and from the hotel to the Wrocław airport;
- c. transfer from the Leszno railway station to the hotel and from the hotel to the Leszno railway station;
- d. transfers between the hotels and the venue of the Conference.

22. Active Participant shall be also obliged to undergo the paper submission procedure in accordance with Annex 1 – Papers.

23. The number of the Participants of the Conference shall be limited. The acceptance shall occur on a first come first served basis. In case of rejecting a participation because of a lack of vacancies, the entire conference fee paid shall be returned.

24. Withdrawal from the appearance at the Conference:

- a. withdrawal by 1 March 2022: the entire conference fee shall be returned;
- b. withdrawal after 1 March 2022: the organiser shall not return the conference fee.

3. The number of the Active Participants of the Conference shall be limited. The acceptance shall occur on a first come first served basis.
4. In order for the abstract and/or paper to be accepted for presentation during the Conference, it is necessary to comply with the following schedule:
  - a. by 30 June 2021: abstract submission;
  - b. by 31 July 2021: information on the acceptance of abstracts;
  - c. by 10 December 2021: paper submission;
  - d. by 10 February 2022: paper acceptance
  - e. by 10 March 2022: registration of participation.
5. The person submitting a paper represents:
  - a. that upon reading the paper, all authors and co-authors mentioned accept the contents thereof and agree to the publication thereof;
  - b. that the work does not infringe any third party rights, particularly copyright, copyright-related rights, industrial property rights, trade secret.
6. By submitting an abstract and/or paper, the Participant agrees to the publication thereof in materials related to the Conference and in the publication published after the Conference (within 12 months from the end of the Conference).
7. The publication referred to in Clause 6 may occur in electronic form (publication on a website, e-book, PDF brochure) or in paper form (book, brochure, etc.).
8. The authors shall not be entitled to remuneration for the use of copyright, pursuant to Clause 6 and Clause 7.
